Relocation of Outpatient Clinics at Mandeville Hospital

Operations of the Mandeville Regional Hospital Outpatient Department will be relocated to the Mandeville Seventh-day Adventist Church hall, 3A Caledonia Road, Mandeville (across from the hospital), as of Wednesday, September 8, 2021.

All outpatient clinics with the exception of the Orthopaedic Clinic will be relocated to this venue.

The clinics will be opened to the public Mondays to Fridays between the hours of 8:00 a.m. and 3:00 p.m. Patients will be allowed to park in the church parking lot.

Where possible, patients are asked to utilize the National Health Fund Quick Prescript programme and the public/private partnership programme with participating pharmacies to have their prescriptions filled. The participating pharmacies include Caledonia Mall, Haughton's and Jermac's pharmacies.
