Job Summary:

Under the general direction of the Chief Public Health Inspector, the Deputy Chief Public Health Inspector coordinates Public Health and sanitation programmes for a number of health districts and acts as deputy to the Chief Public Health Officer or manages the activities of Public Health Personnel engaged in specialized areas of environmental health and sanitation in a region.

Qualification and Experience:

- Ability to recognize hazardous sanitation practises and implement remedial action.

Key Responsibilities

- Participating in planning and organizing programmes for the promotion of environmental health for a zone; monitors the implementation of programmes and evaluates the impact on community health.
- Conducting special assignments and surveys in environmental sanitation and communicable air-borne diseases.
- Monitoring the operating of specialized areas such as occupational health hazards, water and waste control and epidemiological surveys.
- Maintaining strict surveillance on all animals entering the island without permission from the Ministry of Agriculture; on passengers and crew arriving from countries with epidemics and known contagious diseases.
- Monitoring a programme of insect control and malaria surveillance in a region to prevent infectious diseases and promote environmental health; supervises spraying, fogging and other field operations.
- Administering a programme of inspection of buildings and sewer connections at building sites to ensure compliance with Public Health Laws relating to sewerage disposal.
- Administering a programme of surveillance of public water supplies to ensure the safety for human consumption.
- Monitoring surveys of waste water facilities and assesses treatment and disposal systems; liaises with Medical Officer of Health and reports health hazards; makes recommendations for remedial action.
- Assigning work areas of responsibilities to public health inspection staff, clerical and other support staff. Evaluating reports on staff performance and makes recommendations for promotion or transfer accordingly; gives technical advice to staff and demonstrate effective methods of inspection and enforcements; performs follow-up checks on difficult cases that are carried out.
- Participating in planning and immunization campaign in outbreaks of epidemics or high incidence of infectious disease. Monitors control or eradication measures.
- Analysing environmental data submitted from Public Health Inspectors and compile reports, and statistics, investigates and submit reports on special environmental health problems to supervisors and relevant reports to epidemiology unit and other agencies.
- Organizing lectures and gives talks to students, churches and other community groups and individuals.
- Collating data and makes submissions for inclusion in the budget.
